The Absolute Balanced Fund and the underlying managers are measured against Headline CPI for all urban areas.

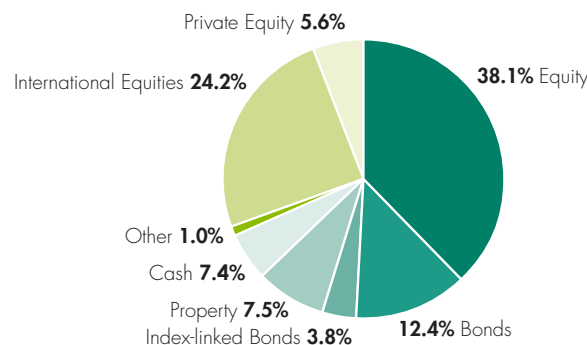

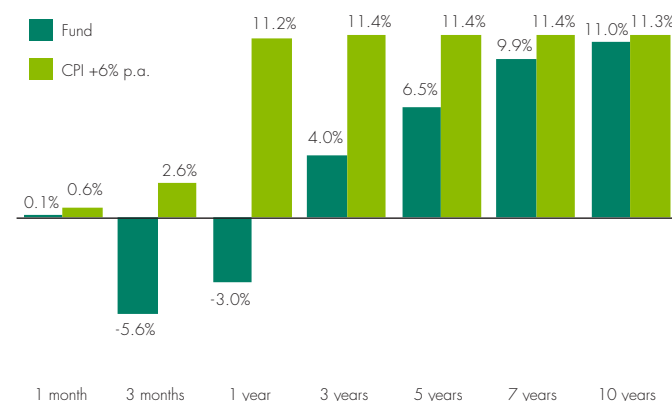

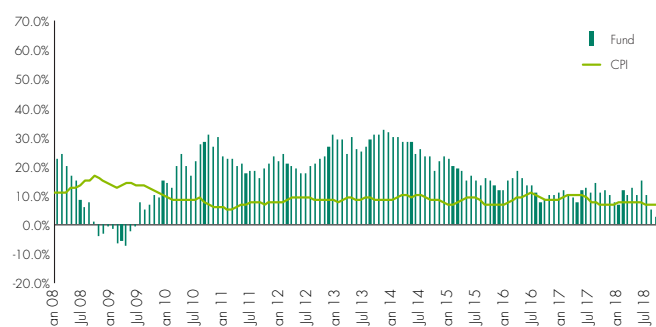
