The benchmark has a 20% weighting in global equities, 40% in global fixed income securities and 40% in US money market instruments. This fund has no emerging market exposure. In order to achieve the fund objective the portfolio manager may choose to gain exposure to the described assets and asset classes by investing through OMLACSA pooled portfolios, collective investment schemes or a combination thereof.

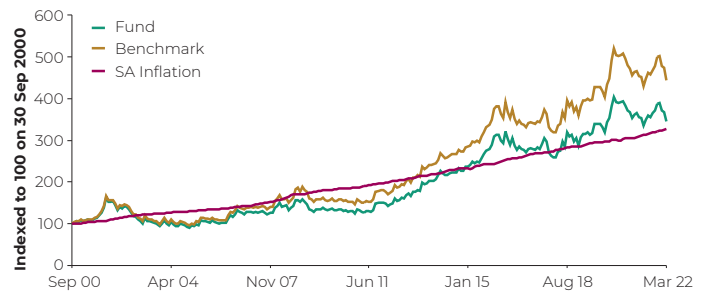

Performance Since Inception



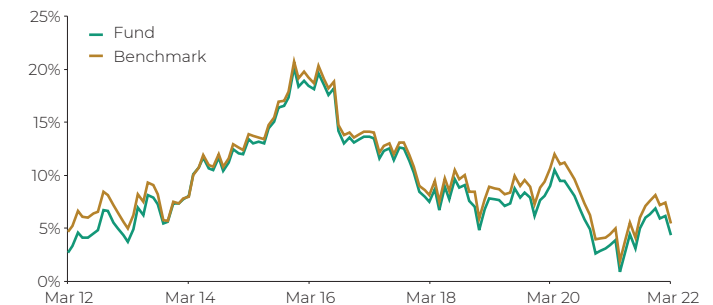
