INVESTMENT DESCRIPTION AND OBJECTIVE

The portfolio has a benchmark of STeFI 3-month and targets returns of 0.5% p.a. above STeFI 3-month (after fees) over periods of 12 months and longer. It invests in short-term money market instruments with a duration of up to 12 months. The portfolio is offered to investors through a life policy.

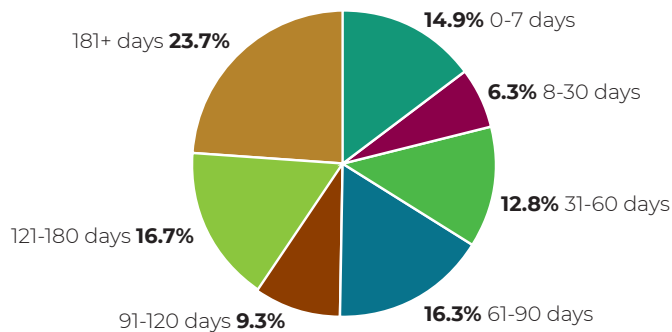

COMMENTARY

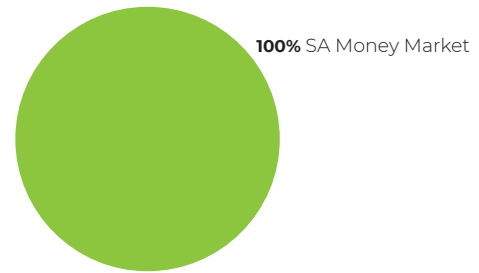
The Fund is conservatively managed, and investments are limited to high-quality instruments. Investments within this Fund have a maturity of less than 13 months and a weighted average maturity not exceeding 120 days, as per legal requirements. The Fund's latest maturity position was 116 days. The Fund's investments are well diversified across a number of issuers and instruments and are therefore considered less risky than a deposit with any one bank. 98% of the strategy was exposed to F1/F1+ rated investments, in other words, a highly rated investment.

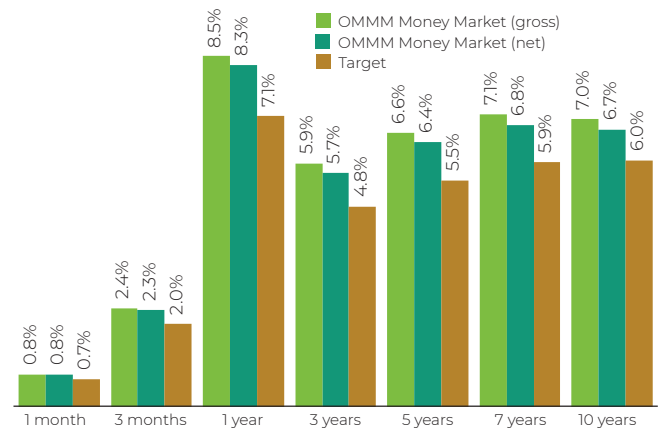

HISTORICAL RETURNS



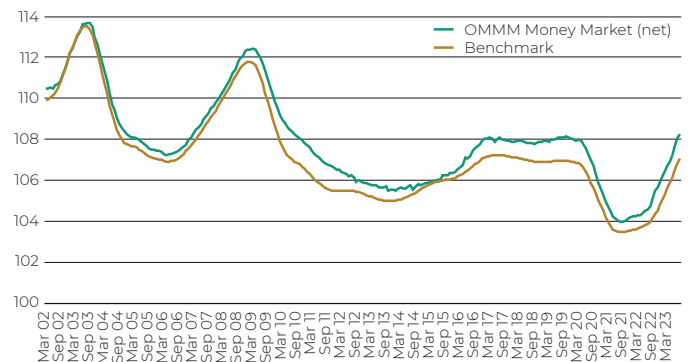
Gross returns are before deduction of all fees but after transaction costs.
