**OLD MUTUAL MULTI-MANAGERS (OMMM) APPOINTS CHIEF INVESTMENT OFFICER AND DEPUTY CHIEF INVESTMENT OFFICER**

I am pleased to announce the appointment of Roland Gräbe as Chief Investment Officer (CIO) and Suvira Bodha as the Deputy Chief Investment Officer effective 1 July 2024 and 1 August 2024 respectively.

**CHIEF INVESTMENT OFFICER**

Roland is not new to Old Mutual group and has held several roles including in Old Mutual Wealth and Old Mutual Multi Managers. He was CIO for Symmetry from 2010 and Head of Customer and Product Management for Old Mutual Multi-Managers from 2013. In 2016 he launched and was responsible for Old Mutual Wealth's Discretionary Fund Management (DFM), Tailored Fund Portfolios (TFP). He leveraged the existing broader OMMM investment process to design model portfolios for TFP and was accountable for investment decisions. In September 2023, Roland was appointed as head of the Old Mutual Multi-Managers retail proposition encompassing the DFM business. He will continue to fulfil this role while we recruit for a replacement.

Roland has an insurance science degree from the University of Pretoria, has passed his SAIFM Registered Persons Exams and is a CFA Charterholder and CFP® professional. He has over 20 years combined investment experience in investment consulting and multi-management.

In his new role, Roland will be responsible for Old Mutual Multi-Managers' investment strategy and process, as well as the management of the investment team. He will report directly to me and continues be a valuable part of the Executive Committee.

**DEPUTY CHIEF INVESTMENT OFFICER**

Suvira joined Sanlam Multi-Manager in 2016 as part of their graduate program with primary responsibilities of manager research, largely on hedge funds. Over the years, her role progressed to include portfolio management. In 2020, she was promoted to Co-Head of Alternatives, where her responsibilities were extended to creating investment solutions involving the full opportunity set of Alternatives, including private equity, mezzanine debt, infrastructure, and private credit over and above hedge funds. In 2021 she took on the full role of Head of Alternatives, whilst continuing her responsibilities as portfolio manager to both the retail and institutional client bases. In 2023, she was appointed Co-Deputy CIO of Sanlam Multi-Manager, driving the strategic planning and execution of the investment process.

Suvira holds a business science degree specialising in Analytics from the University of Cape Town. She is a CFA Charterholder and an academically qualified actuary, as a student of the Institute and Faculty of Actuaries.



In her role as Deputy CIO, Suvira will work closely with the CIO across all aspects of the investment process and overall strategy. She will be directly responsible for the manager research process and team. Suvira will also manage some of the key relationships with business partners to ensure the success of the multi-manager. Suvira will report to Roland.
