INVESTMENT DESCRIPTION AND OBJECTIVE







HISTORICAL RETURNS




Gross returns are before deduction of all fees but after transaction costs.

COMMENTARY

The Fund is conservatively managed, and investments are limited to high-quality instruments. Investments within this Fund have a maturity of less than 13 months and a weighted average legal maturity not exceeding 120 days. The Fund's latest maturity position has not exceeded 120 days. The Fund's investments are well diversified across a number of issuers and instruments and are therefore considered less risky than a deposit with any one bank. 97% of the strategy was exposed to F1/F1+ rated investments, in other words, a highly rated investment.
